

## ASHLEY NEWMAN LEADS USCS MODIFIEDS AT CLAYHILL

TN &ndash; October 15, 2016 - Ashley Newman of Ripley, TN won the 25-lap USCS King of the Hill main event for the K&N Filters USCS Outlaw Modified Series on Saturday night at Clayhill Motorsports. Newman, who was the series 2008 Champion before moving on to Late Models, recently hooked up with 2014 K&N USCS Modified Rookie of the Year Preston Seratt for a ride in the inaugural USCS King of the Hill event at the track. It was Newman&rsquo;s first trip to the www.RockAuto.com USCS Victory Lane in a number of seasons and the win and celebration was popular with this group of West Tennessee race fans.

Newman

took the lead following a caution on lap 22 when then race-leader Shane Aiken from Medina, TN made contact with a lapped car taking him out of contention. A past Clayhill Motorsports track Champion and winner of the recent Cotton Bolt Cup, Matt Cooper from McKenzie, TN raced past several cars over the final three laps after starting eighth to take the runner-up spot. The K&N Filters Podium Award and third place check went to Newman&rsquo;s new team-mate and car-owner Preston Seratt of Dyersburg, TN. Past track Champion, Bart Richardson of Bradford, TN finished fourth and Greg Welch of Sardis, TN was fifth.

The

2013 K&N Filters USCS Outlaw Modified Series Champion, Troy Dow of Mumford, TN led the next group in sixth place and Junior Lemmings of Jackson, TN was seventh. Hunter Wilbanks of Lakeland, TN finished eighth and ninth place went to David Esch of Gleason, TN. Current Crowley&rsquo;s Ridge Raceway track Champion, Paul Reeder of Malden, MO rounded out the top ten. In preliminary action, the three eight-lap heat races were won by 12-year-old Hunt Gossum from Mayfield, KY, Troy Dow, and Bart Richardson.
